BLUE BRIDGE

Jenni Bricker, citizen, came to the council to discuss her efforts to save Bridge #3430 known locally as the blue bridge located on SR 26. There have been concerns whether the bridge referenced in the INDOT report is even the same bridge as she believes the bridge is structurally safe. The report from INDOT reads the bridge shouldn't be open to large traffic such as Semi-Trailers, Trucks and Farm Equipment.
